Consideration of Amendments - Policy 58 - Playground Funding Policy

Notice of consideration of amendments to Policy No. 58 "Playground Funding Policy", was given at the August 13, 2012 Council meeting. It is proposed that the policy be amended to provide for a maximum grant of \$2,500.00 to be cost shared on a 50/50 basis. These amendments will result in the yearly total funding being reduced from \$5,000 to \$2,500 per request.
