#### PRESENTATION FROM WESTERN REGIONAL ENTERPRISE NETWORK (REN)

Angelique LeBlanc. CEO, presented to Committee of the Whole regarding the work of the Western REN. Angelique was accompanied by Mayor Pam Mood from Yarmouth who is the Chair of the Liaison and Oversight Committee for the Western REN, and Allister Surrette, who is the Deputy Chair of the Board for the Western REN.

Angelique discussed the formation of RENs in the province, the process for the start-up and structure of the Western REN, and also discussed the projects and priorities of the Western REN.

There was lots of good discussion about economic development in the region, and the benefits of partnering with other municipalities for large scale projects such as attraction, or internet improvement.

The three representatives were thanked for their presentation and left the meeting.

#### Draft Floating Dock Policy

Discussion took place regarding the draft of the Floating Dock Policy. Changes suggested included reducing the allowable duration to 12 hours, removing the sections regarding servicing and refueling, and to add a section regarding video surveillance. These amendments will be made and brought back to CotW for further review.

#### TRAINING SESSIONS FOR COUNCIL AND STAFF

Discussion took place regarding the need for time to provide training for both council and staff. CAO discussed the need for cross-training of staff, and councillors are supportive of the administration/tax office being closed one afternoon a month for training purposes. It was agreed

that this would be well advertised in multiple media formats each time to ensure residents have as much notice as possible.

It was further discussed to arrange training sessions for Councillors on a quarterly basis that will occur outside of regularly scheduled Council or Committee meetings.

It was requested that the CAO have regular hours of operation posted on the front doors of the Municipal Building.

#### PROVINCIAL ANNOUNCEMENT REGARDING FINANCING FOR WATER ISSUES

The announcement from the Provincial Government regarding an amendment to the MGA that would allow Municipalities to finance the improvement of water systems was discussed. The program will be similar to the PACE Program that allows for energy efficient upgrades to be done to residences. A by-law and policy will need to be discussed and developed. Committee had some basic ideas and principles that they wanted to see included which will be discussed further at future meetings.
