BARRINGTON BAY TRAIL CONDITION

During discussion of this matter it was noted that funding had been provided to the Woodland Multi-use Trails Association for maintenance and upkeep of this section of trail. It was agreed that the Association be asked to address the condition of the trail as soon as possible.

A number of other suggestions were brought forward relating to trail maintenance which will be pursued by the CAO, should the Association fail to take action.

SHEROSE ISLAND NATURE TRAIL

Concern was expressed regarding the condition of the Sherose Island Nature Trail. It was noted that the entire area is currently being assessed and many changes will take place in the future.
