MPAL - MEMORANDUM OF UNDERSTANDING APRIL 1 - 2019 - MARCH 31, 2024

It was reported that our agreement for the MPAL Program expired March 31, 2019. A new Memorandum of Understanding for the period of April 1, 2019 to March 31, 2024 was circulated to members in advance for their review. The new structure is based on the Province's new action plan for increasing physical activity called "Let's Get Moving Nova Scotia".

Under this agreement, the Department of Communities, Culture and Heritage will provide funding in the amount of \$30,000.00 per year to be applied towards the salary, benefits professional development and travel of MPAL Staff to develop and implement the Plan for the MPAL Program. \$5,000.00 of the \$30,000.00 is being provided to extend the program to the Town of Clarks Harbour. The Municipality's commitment is a minimum of \$20,000.00 per year to the program. Including program costs, the Municipality's yearly cost is approximately \$25,000.00.

The Barrington Port LaTour Volunteer Fire Department is requesting a loan guarantee from the Municipality in the amount of \$265,000.00 for the purpose of purchasing a new fire truck.

Being duly moved and seconded that it be recommended to Council that the following resolution be approved:

WHEREAS the Barrington Port La Tour Fire Department is registered with the Municipality of The District of Barrington;

<u>AND WHEREAS</u> the Barrington Port La Tour Fire Department has determined to borrow the aggregate principal amount of Two Hundred and Sixty-Five Thousand Dollars (\$265,000) for the purpose of firefighting equipment;

<u>AND WHEREAS</u> the Barrington Port La Tour Fire Department has requested a municipality to guarantee the said borrowing;

AND WHEREAS Section 294(6) of the Municipal Government Act provides that a municipality may grant or lend money to, or guarantee a loan for, a registered fire department for operating or capital purposes;

<u>AND WHEREAS</u> Section 88(3) of the Municipal Government Act provides that no guarantee of a borrowing by a municipality shall have effect unless the Minister of Municipal Affairs has approved of the proposed borrowing or debenture and of the proposed guarantee;

BE IT THEREFORE RESOLVED

<u>THAT</u> the Municipality of the District of Barrington does hereby approve the borrowing by the Barrington Port La Tour Fire Department of Two Hundred and Sixty-Five Thousand Dollars (\$265,000) for the purpose set out above;

<u>THAT</u> subject to the approval of the Minister of Municipal Affairs of the guarantee, the Municipality unconditionally guarantee repayment of the principal and interest of the borrowing so made;

<u>**THAT**</u> upon the issue of the debentures, the Warden and CAO of the Municipality do sign the guarantee attached to each of the debentures and affix thereto the corporate seal of the Municipality.

BATTING CAGES

The purchase and installation of batting cages was briefly discussed.

It was agreed that funding be provided in the 2019-20 Municipal Budget for the purchase of batting cages.
