APPROVAL OF AGENDA

Being duly moved and seconded that the agenda be approved as amended.

APPROVAL OF MINUTES

Being duly moved and seconded that minutes of the regular meeting held July 12<sup>th</sup> and the special meeting held July 13, 2021, be approved as circulated.

FINANCIAL REPORT

Leah d'Eon, Director of Finance appeared before the meeting and presented the quarterly financial report to June 30, 2021. Explanations were provided where necessary.

A copy of the Financial Report is attached and forms part of the minutes.

Leah was thanked for her presentation and left the meeting.

FIREFIGHTERS RECOGNITION

It was suggested that consideration be given to acknowledging exemplary service of volunteer firefighters.

It was agreed that the suggestion be discussed with the Fire Services Co-ordinator to determine whether any changes should be made to policy.

DRAFT AMENDMENTS - POLICY 42 "MUN. GRANTS AND SPONSORSHIP/ADVERTISING POLICY"

As requested by members, Policy 42 "Municipal Grants and Sponsorship/Advertising Policy" has been revamped to provide for different applications based on amount of funding being requested and to include a section for road improvement grants.

It was suggested that the grant amounts be adjusted, receipts and financial information be required, etc.

Staff will make changes to the policy based on discussions and present the draft policy back to committee for review.

BARRINGTON MUNICIPAL EXHIBITION COMMITTEE – REQUEST FOR LETTER OF SUPPORT AND FUNDING

Brenda Maxwell, member of the Barrington Municipal Exhibition Committee, was present for this portion of the meeting.

It was reported that correspondence has been received from the Barrington Municipal Exhibition Committee which advised that they are applying for federal funding to carry out improvements to their grounds. They advised that they are in need of a well and an expansion to their oxen barn as well as repairs to their horse barn and a new storage building. They are applying for funding in the amount of \$100,000 which requires them to contribute 25%. The committee is requesting Council for a letter of support to accompany their application and a loan of \$25,000.

During discussion it was noted that the Municipality recently provided a grant of \$3,500 to the Exhibition Committee to assist with the cost of a well. Ms. Maxwell acknowledged the grant and advised that they would only be requesting a loan of \$21,500.

Question was raised as to whether the Municipality would be permitted under the MGA to loan money to an organization for this purpose. The CAO informed members that the matter would have to be researched before proceeding. It was noted that a policy or by-law would also be required. Information will be gathered and brought back to the committee.

Being duly moved and seconded that it be recommended to Council that a letter be provided to the Barrington Municipal Exhibition Committee in support of their application for funding.

Motion carried unanimously.

LOBSTER TRAP CHRISTMAS TREE ENHANCEMENTS

During budget deliberations \$15,000 was allocated to the construction of a new and improved Lobster Trap Christmas Tree. A staff report has been prepared, seeking direction from Council on how to proceed. A copy of the report is attached and forms part of the minutes.

SUBJECT: Lobster Trap Christmas Tree Enhancements

### ORIGIN

After more than a decade of assembling a lobster trap Christmas tree on the North East Point waterfront, Council has budgeted an investment of \$15,000 to build a new and improved tree. This report has been prepared to seek direction from Council on how to proceed.

### BACKGROUND

The building of the tree and its lighting ceremony have become a tradition in the Municipality that has gained notoriety throughout the province – with other Nova Scotia communities joining us, including Lunenburg, Port Mouton and Musquodoboit Harbour, which has a small lighthouse atop its tree.

As we know all too well, the tree is cherished by many. It is adorned with approximately 130 wooden and plastic buoys, each painted in a unique pattern and placed by family and friends of lobster fishermen and women in memory of those lost at sea, those who have since passed on, as well as those who were, and still today are fishing the waters along our rugged coastline.

Nearly 200 salvaged traps/pots make up our tree, all which have served their duty catching thousands of lobsters on the bottom of our ocean floor. The tree, as all Christmas trees do, brings families, friends and in this case, our wonderful community together to celebrate the Christmas and lobster season and remember loved ones. It's a reminder of the importance the lobster industry plays to our communities, residents, businesses, not only here in the Municipality of Barrington but to the entire province of Nova Scotia.

### DISCUSSION

Our lobster trap Christmas tree has taken on a few different looks over the years. This is due, in part, to the use of salvaged traps from our C&D Site, the varying experience of the assembly crew and the weather.





Traditions represent a critical piece of a culture. They help form the structure and foundation of a community and they remind us that we are part of a history that defines our past, shapes who we are today and who we are likely to become.

As does every longstanding tradition, they evolve over time. Our tree is no different and every tree we've assembled has had its unique personality. That said, there seems to be a desire for a new and improved tree that could be consistently recreated every year, thus enhancing the tradition.

Typically, upon approval by Council, the details of a project or service are executed by staff but seeing as this is so important to the residents of our Municipality and reflects on its image, we felt we required more direction on what Council envisions.

In an effort to provide Council with options, we researched the look and feel of a number of different trees that exist locally and abroad. Following our research, we determined that the trees from Rockland, Maine and Gloucester, Massachusetts would be two examples of trees that would be achievable for us and would fit the look and feel of our Municipality.

**Rockland, Maine Tree**

The tree built in Rockland, Maine is roughly 40-feet tall, is made up of 155 traps and 2,500 Christmas lights and is assembled entirely by volunteers.

The tree is a part of Rockland's Festival of Lights, a 25-year-old tradition that takes place just after Thanksgiving and runs through Christmas. For about the past 10 years, Rockland Main Street Inc. has been organizing both the Festival of Light and the lobster trap tree.







### **Gloucester, Massachusetts Tree**

The Gloucester tree is about 45-feet tall and is built from 350 traps. The idea behind the tree began in 2001 by Janice Lufkin Shea, a downtown business owner. Jeff Worthley started it and built it for 10-years and then handed it off to other members of the community.

Local lobstermen donate their traps and volunteers work to build it. The fire department uses their hook and ladder to set the star at the top.

### **BUDGET IMPLICATIONS**

The way we currently assemble the tree costs the Municipality very little. As mentioned, the traps are salvaged from our C&D Site and Staff of the Department of Property Services physically assemble it. The only real cost is staff time, the renting of a boom lift to help us place the traps towards the top of the tree and some lights.

As you will read in our recommendation, we believe we can achieve the desired outcome without the need for much of the allocated funds.

That said, if our recommendation is rejected or does not work out, we recommend investing the allocated funds in the construction of a metal frame and the purchase of new traps. This would achieve the goal of creating a new and improved tree that could be replicated year after year as the frame and new traps would solidify the tree and keep the shape consistent.

It is estimated that the cost of a new trap (basic rectangle box nothing else) would be approx. \$80 each.

### **RECOMMENDATION**

After careful consideration, we recommend assembling the tree similar to Gloucester's.

In addition to this recommended design, I've said many times that a project or initiative is never as successful than when it is born or has significant buy-in from the community. As you will read in the articles, the two trees we provided as options began and continue to be built and led by the community.

We have also seen the benefits of involving the community firsthand through one of our largest events – the Nova Scotia Marathon. Since creating our marathon committee, the event has improved substantially.

Although many cherish the tree, its assembly and lighting ceremony are still entirely led by the Municipality. In order to achieve the desired consistency and pride of a new and improved tree, we recommend the following:

1. Solicit donations of either a new trap or good used trap (with specific dimensions) from our local fishers/residents/businesses. Each trap could have a tag placed on it with either details on who it has been donated by or in memory of a loved one. Such a campaign could start in the summer and run until October, or until we reach our goal.
2. Form a committee to help build the tree. We could issue a call for volunteers to work on the tree for a few days and the team could meet prior to building it to go over the construction process and how that will work.
