The Shelburne County Archives & Genealogical Society was founded in 1987 by a group of individuals interested in genealogy, preserving and conserving the history of Shelburne County and promoting good standards in genealogical research. In 30+ years the members of our Society have spent numerous hours volunteering to continue our mandate, including transcribing all gravestones in the county, preserving records, writing books and assisting researchers to name a few.

**3. Please identify the community, area and/or group(s) your organization serves:**

The Shelburne County Archives & Genealogical Society holdings include records, photos and data relative to all of Shelburne County. Our membership is approximately two hundred, spanning across Canada and the United States. Our meetings have alternated between Shelburne and Barrington for many years with guest speakers from different communities and with a wide variety of knowledge about local interests. We often assist with university student's thesis, authors writing books and research projects for elementary/high school students. Throughout the year we appear at various community groups to do talks/lectures about genealogy and archives. We previously put together a display entitled "Life on the Water" which was widely received when we launched it at the Lobster Expo. We also launched a book about the Beaverdam Sports Meet. Not only was it well received but it has been our best seller to date. We often do partnership outreach with the Western Counties Regional Library, Shelburne branch. This is a nice partnership in the direction of community outreach with the Library as we leave our displays for several weeks for their patrons to enjoy. We continue to receive interesting material from local residents and those from afar with Shelburne County ties that we house and researchers can use.

**4. Please describe your organization's specific project/program/service:**

We are seeking funding in order to hire an IT specialist that will be able to network our office computers, laptops and tablets. This will allow us to work on projects more efficiently, as our databases will be able to be accessed and updated more easily. The past 2 years with COVID and limitations on working in the office and together in person has also highlighted the need to be able to access certain features and information at a distance. Proper networking and development of our systems will allow us to have more volunteers work from home and ensure that regardless of any limits of the number of people able to gather or restrictions on gathering together we can still proceed with ongoing/long term projects. This further ensures our limited revenue is not interrupted or stalled, which is crucial to our continued success and future.
