
We, the undersigned members of the Goose Lake Association Ltd., which includes Goose Lake Road Extension, are writing to express our deep concern regarding the camp leases surrounding our properties and the use of our private roads by the leaseholders. The private roads maintained by the Goose Lake Association Ltd. (which include Scotia Drive, Gander Lane, Lake View Drive and Goose Lake Road Extension), are not designed to handle the increased traffic resulting from the camp leaseholders. This additional use leads to accelerated wear and tear, increasing maintenance costs and reducing the lifespan of our roads. Despite using the roads, these leaseholders do not pay the maintenance fees that our residents do, unfairly shifting the financial burden onto us.

Given these concerns, we urge the Municipal Council to take the following actions:

- We request that no new camp leases be issued around Goose Lake to prevent further strain on our community's resources and infrastructure.
- We ask that no existing camp leases be relocated in a manner that increases their impact on our private roads and the surrounding area.
- We urge the Municipality to review and enforce the terms and conditions of the camp leases and to implement measures that protect our community and environment.

We believe that addressing these issues is crucial to maintaining the safety, security, and quality of life for the residents of the Goose Lake community. We appreciate your attention to this matter and look forward to your prompt response.
