

**NOTICE
LOW INCOME PROPERTY TAX EXEMPTION
MUNICIPALITY OF THE DISTRICT
OF BARRINGTON**

The Municipality of Barrington provides a property tax exemption for low income earners. For more information on this program, please pick up a copy of the Low Income Property Tax Exemption Policy at the Municipal Office or view the policy on our website at www.barringtonmunicipality.com.

Applications for the 2021/22 taxation year must be filed at the Municipal Office **not later than September 30, 2021**.

In order to qualify for an exemption, the Applicant's income (Line 150 of their Notice of Assessment from Revenue Canada Agency) and total income of **ALL** persons residing in the household (excluding War Veterans Allowance) for **2019** must be:

- less than \$21,000 - grant exemption \$400
- more than \$21,000.01 but less than \$25,000.00 - grant exemption \$300
- more than \$25,000.01 but less than \$30,000.00 - grant exemption \$200

Applicants must provide a copy of their **2019** Notice of Assessment from Revenue Canada as well as copies of the Notices of Assessment from Revenue Canada from all persons residing in the household.

The property owner's previous year's rates and taxes must be paid in full at the time of their application.

The exemption shall only be available for property owners where the property is their primary residence occupied by him/her.
